- Pramod Sharma: Lisa based on experience, how much time it takes to get the stakeholders together at National Level.
- Linda Keane: Thank you for sharing these encompassing strategies for connecting schools, teacher training, communities, and environmental education.
- Mireille Digard: Interesting that in England it's just 10 topics! Is the one we are missing "climate action"?
- Mariam Kabamba Merry: Do you have also French or Swahili curriculum?
- Pramod Sharma: Climate Action usually is cross cutting theme
- Pramod Sharma: Hi Mariam yes many resources are available in French
- Bidhan Chandra Pal: In light of the successful case studies and best practices being developed in Greening Education, what steps can be taken to disseminate these examples from one country to another? It is worth mentioning that Bangladesh has already established significant examples through FEE's environmental education initiatives.
- Pramod Sharma: Programme in French https://www.eco-ecole.org/
- Alicia Torres: What types of instruments are used to gather the data to measure the impact? Is that gained from the applications alone?
- Linda Keane: NEXT.cc STEAM by Design introduces Nature and the built environment together.
 Awarded a United States Green Building Excellence in Green Building Education, a National Association for Environmental Education
- Bidhan Chandra Pal: Given that Bangladesh, like many countries, faces a limited budget for education, what effective strategies can we implement to enhance funding and support for environmental education? This is crucial for equipping students with a deeper understanding of their environmental impact and fostering sustainable practices.
- Mohun Cyparsade: Hello everyone; The MIE trains teachers for field work, outdoor activities too, but we can definitely collaborate further. We have field visits to environmentally sensitive areas and undertake collaborative discussions on relevant issues.
- Neloba Ngozire: Are there programs for teacher exchange, resources and learners with your country partnership?
- Pramod Sharma: From discussions with stakeholders and experience of Office for Climate Education
 a minimum of 50 hours training is required for teachers
- Lisa Tang-Chong: Right now I would say approximatively a year. But this is mostly because we have the evidence of how the programme is being implemented and the impact it has on the schools and community. When we first started, I would say 2 to 3 years.
- Olivia Copsey: Alicia the schools develop their own monitoring and evaluation processes as part of the Eco-Schools Seven-Steps and report during their Green Flag process. Several National Programmes also have online evaluation platforms for comparative data collection.
- Judy Braus (she, her) NAAEE: We'll get to these questions at the end, including talking about evaluating EE programs and the many ways we're all evaluating our efforts.



- Pramod Sharma: This is how it should be done All teachers should be trained to deliver EE/ESD.
- Sydney Abbott: No question! Didn't realize I had it up!
- Nina Hamilton (NAAEE) (she, her): Congrats on such a great program! Exciting to see it continuing to grow.
- Pramod Sharma: This could be a good case study for Pillar 4!!
- Lisa Tang-Chong: Almagul, I would definitely encourage you to approach your Ministry of Education
 and if your Ministry of Environment has an education department, that is the way to go too. Your
 UNESCO NATCOM should also be able to support you if your country has agreed to the GEP.

- Ian Humphreys (FEE & GEEP): HI Almagul. A few thoughts in regards to your question. Approaching government for funding takes time and requires relationship building (and ongoing maintenance) at both the Ministerial and staff levels. Being able to back your claims of the benefits of EE eg with site visits, can make a big difference. Finally, alignment with government targets can be an important lever for funding. In NI Local Authorities support for Eco-Schools has been predicated on how it helps deliver on waste targets (with knowledge travelling through children into their homes).
- Bidhan Chandra Pal: How can we leverage environmental education programs as revenue-generating models to promote their sustainability? What are the practical strategies and feasibility of implementing this approach? At present, we are exploring innovative initiatives in Bangladesh aimed at this transformation, and we are eager to expand our efforts and collaborate on a larger scale in the future.
