Emory Harger: We didn't have a staff comms person until September 2023, growing as an

org, so building this now.

Anticipate and think ahead

Vanessa Barela: What about using templates/messages? How do you do this authentically because they can seem performative.

Sarah Bodor: Two questions--how important is it that representatives of the community most impacted by the event have vetted the messaging? And to what extent should timing be a factor in whether you make a statement? For example, your conference is two days after a global crisis or natural disaster takes place? Does that matter?

Richard Tusabe: What if the crisis isn't within nitch or organization, but somehow it affects me and how I do my work, such as the war in Gaza as you have mentioned.... or maybe, wouldn't that feel like one is crossing the line?....And I think such fears are the ones keeping people away from such incidences but suffer with internal conflicts....



Nathan Broaddus: How do you balance the legal risks of speaking out to your community when the crisis is a legal one for your organization and you may be constrained in what you can say because of an active or threatened lawsuit?

Richard Tusabe: This tool is really great even for self-behavioral check

Deleting critical posts/comments can often make the situation worse, but on the other hand, leaving them out there feels vulnerable.

Holly H: @ Richie that has happened to my colleague who is Jewish. I think showing empathy in important. It must be hard to be working in an organization that may not have empathy for you or your crisis. The least I can do as a colleague is show care for them,
