| <p>A) Processes that shape the Earth— Learners understand the major physical processes that shape the Earth. They can relate these processes, especially those that are large-scale and long-term, to characteristics of the Earth.</p> | <p>1. The sun is the primary source of energy for Earth’s climate system.
